Individuals, and PACS (other than Small Contributor Committees), may contribute a maximum of \$5900 to each committee, per election.

If your contribution(s) to these committee(s) and to other California state or local committees total(s) \$10,000 or more in a calendar year, California law requires you to file a Major Donor Committee Campaign Statement (Form 461). The deadline and location for filing this statement will depend upon the timing and type of contribution(s) you have made.
