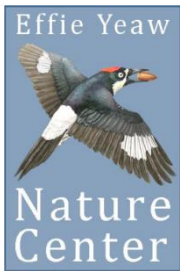

ONLINE CLASSROOM PROGRAM POLICIES

We thank you for choosing the Effie Yeaw Nature Center for your educational program! Research shows that humans are happier, healthier and smarter through more contact with the natural world, which is more important than ever before.

Our two most important goals for your program:

- 1. A high quality and engaging educational experience.**
- 2. A safe and enjoyable virtual nature encounter.**

With these important goals in mind we have set up procedures that will help maintain safety for your group and will assure your students gain the maximum benefit from their educational program.

Reservations: All reservations are made on a “first-come, first-served” basis and processed according to date requested. At least two weeks advance registration is required. Reservations are confirmed when you receive an invoice from the scheduling department. **Do not assume you have a reservation until you receive your invoice. This serves as the confirmation for your program.**

Payments:

- Cash, checks or credit cards (MasterCard, VISA or American Express) are accepted.
- **Program payments are due on receipt or at least two (2) weeks prior to the program date. Make checks payable to EYNC.** Checks returned for insufficient funds will be charged an additional \$35 fee.
- **Payments not received by the due date stated on the invoice may result in the cancellation of your reservation.**

Rescheduling: One rescheduling change request may be accommodated per invoice depending upon staff and program availability **and if requested at least two (2) weeks prior to the program.** A \$25 service charge will be charged for each time a program or service is rescheduled. Programs will not be rescheduled less than two (2) weeks before the program date.

Cancellations: **A \$50 cancellation fee** will be charged for any program cancelled within 14 days of the program date.

Group Size: Online group programs can have a maximum of 35 students. A refund will not be given if fewer participants attend than the number listed on the invoice.

Intellectual Property: **Recording of Presentations is strictly prohibited.** No individual or entity may electronically record or broadcast any portion of the Virtual Nature Encounter or any other presentation produced by/for EYNC without prior written consent of Effie Yeaw Nature Center. If you are interested in any of the materials presented during your virtual nature encounter, please contact us.
